# TWENTIETH STEERING COMMITTEE MEETING OF THE SOUTH ASIA FORUM FOR INFRASTRUCUTRE REGULATION (SAFIR)

Venue : Taj Samudra Hotel

Colombo (Sri Lanka)

**Dates**: 28<sup>th</sup> – 30<sup>th</sup> January, 2014

Dr. Bandula Perera, Deputy Chairman, Public Utilities Commission of Sri Lanka welcomed all the members of SAFIR. He expressed his gratitude for selecting Colombo as the venue for the SAFIR's Steering Committee Meeting. He reiterated the commitment of his Commission to furtherance of activities of SAFIR.

The welcome address of Dr. Perera was followed by the address of Shri Gireesh B. Pradhan, Chairperson, CERC. Shri Pradhan apprised the members about the initiatives of SAFIR. He informed that in 2013 the flagship Core Course was organized at LIRNEasia, Sri Lanka and an Investment Conference on Infrastructure Regulation was also organized during 2012 at Mumbai. He however, underscored the need for enhancing the visibility of SAFIR through active co-operation of all the member organizations. Shri A.R. Khan, Chairperson, Bangladesh Energy Regulatory Commission and the present Chairperson, SAFIR in his keynote address welcomed all the members of SAFIR. He recalled that previous Steering Committee meeting was held in Bangladesh. Back to back with the meeting, an international workshop was also organized that helped establish SAFIR as a forward looking organization in the South Asian Region. He stated that SAFIR should endeavor to take all necessary steps to achieve the basic objectives that went into its formation. SAFIR provides a good platform for experience sharing on infrastructure sectors in South Asian Regions. There was an urgent need for further strengthening SAFIR in the interests of all member organizations of the Forum.

The Steering Committee thereafter took agenda items for consideration.

# Agenda Item No. 1:

Confirmation of the minutes of the  $19^{th}$  SC meeting of SAFIR held during  $09^{th}$ - $10^{th}$  May, 2012 at Dhaka (Bangladesh) and the Action Taken Report.

The Steering Committee noted and discussed the Action Taken Report and endorsed the minutes of meeting held during 09<sup>th</sup> - 10<sup>th</sup> May, 2012 at Dhaka (Bangladesh).

#### Agenda Item No. 2:

Financial Statement of SAFIR for the year 2012-13 and Budget for the year 2014-15.

Shri S.K. Chatterjee explained the salient features of the Balance Sheet and Income & Expenditure Account for the financial year 2012-13 (as per **Annexure-I** and **II** of the said Agenda). After discussion, the Annual Accounts of SAFIR for the financial year 2012-13 were considered and adopted.

The budget for the FY 2014-15, as circulated was discussed in detail. It was informed that during the FY 2013-14, there was no professional staff (like Research officer or Senior Research Officer) in SAFIR Secretariat. Paucity of funds was one of the reasons for this. SAFIR activities were being managed by borrowing the services of Research Associates of CERC.

Attention was drawn to note at S. No. 6 of Annexure-II to Agenda Item No. 2, wherein it was discussed that in order to enhance the visibility and activities of SAFIR, there was a need to engage a Consultancy Firm on retainership basis or appoint a Senior Research Officer / Research Officer at professional level specifically for SAFIR. This would require enhancement of existing membership fee as also payment of past arrears by all the member organizations. The members noted that the

membership fee included inter alia travel cost for all member organizations for attending Executive Committee/Steering Committee meetings and also travel cost of regulatory staff for Core Course. The need for increasing the effectiveness of SAFIR was reiterated. After discussion, the following was decided:

• Increase in the membership fee of SAFIR as proposed was approved. The

revised fee to be effective from 01.04.2014 would be as under:

o Consumer Bodies: USD 500

o Academic / Research Institutions: USD 2000

o Regulatory Bodies: USD 4000

o Corporates/Utilities: USD 5000

• The Member organizations of SAFIR paying the membership fee in INR shall

pay at the applicable exchange rate of USD, prevailing as on the date of

payment.

• Till date, The Energy and Resources Institute (TERI) has been paying the

membership fee under the category of Consumer Bodies/NGOs. However,

since TERI falls under the category of Academic/Research Institutions, it is

liable to pay the membership fee under the aforesaid category (of

Academic/Research Institution).

• It was also highlighted that the membership fee was due from several members

and this caused a challenge in carrying out the activities of SAFIR effectively.

It was decided that SAFIR Secretariat would write to these members, to pay the

outstanding membership fee of SAFIR at the earliest.

After deliberations, the proposed budget for the year 2014-15, with above

modifications was approved.

# Agenda Item No. 3:

Report of 12<sup>th</sup> Core Course and conducting of the next Core Course on Infrastructure Regulation and Reforms.

The Steering Committee noted the report of the 12<sup>th</sup> Core Course of SAFIR held at LIRNEasia, Tulhiriya, Sri Lanka during 05<sup>th</sup>-08<sup>th</sup> March, 2013.

The proposal for organizing the 13<sup>th</sup> Core Course of SAFIR during March, 2014 in Bangladesh was approved.

# Agenda Item No. 4:

## **Next Chairmanship of SAFIR.**

After discussion, Ms. Pushpa Wellappili, Acting Chairperson, Public Utilities Commission of Sri Lanka (PUCSL) was unanimously elected as the next Chairperson of SAFIR for one year.

# Agenda Item No. 5:

# **Proposed Infrastructure Conference.**

The proposal for organizing an Infrastructure Conference on Opportunities and Challenges in Infrastructure Sector in South Asia during the FY 2014-15 in New Delhi or Mumbai, India was approved.

# Agenda Item No. 6:

# **Expanding Membership Base of SAFIR.**

Maldives Energy Authority (MEA) had expressed its willingness to become a member of SAFIR. It was decided to include MEA as the member of SAFIR under the category of Regulatory Bodies.

# Agenda Item No. 7:

## Virtual Working Groups.

The members underscored the need for greater visibility of SAFIR. The idea for Virtual Working Group (VWG) was conceived with due regard to the constraints of travelling between countries. After discussion, the participating members agreed to extend their co-operation in operationalising the VWG and designate a Nodal officer to coordinate the activities of VWG with SAFIR Secretariat.

## Agenda Item No. 8:

#### Plan of Action for the year 2014-15:

After discussion, the following was decided for the FY 2014-15:

- A study to be conducted on 'Integrated Development of South Asian Region: Regulatory Issues on Cooperation in South Asia'.
- Operationalisation of the Virtual Working Groups.
- The Executive Committee of SAFIR to meet more often for preparing the road map for future activities of SAFIR.
- Member organizations to extend technical support to SAFIR Secretariat
  in undertaking the various activities specially Operationalisation of
  Virtual Working Groups and commissioning of studies on various
  subsectors of Infrastructure Sectors in South Asia.

A vote of thanks was extended by Shri Sushanta K. Chatterjee, Joint Chief (RA), CERC. He conveyed his sincere thanks to all the dignitaries present in the meeting and conveyed his gratitude and appreciation for the entire team of Public Utilities Commission of Sri Lanka (PUCSL) for organizing the Steering Committee meeting at Colombo (Sri Lanka). He also thanked the staff of "SAFIR" Secretariat for their arduous efforts at organizing the meeting.

The meeting ended with a vote of thanks to the Chair.
